

The Community Drugs Partnership

- In addition to reviewing and updating the membership of the Partnership, to assess and respond to need around alcohol and drugs in the local community, we set up a Drugs Strategy Young People's Education, Prevention and Treatment Group to address needs specifically related to young people
- Added value continues to be delivered through the alignment and tripartite relationship between the Community Safety Partnership, the Safeguarding Adults and Children's Boards.



Reducing Drug Harms

Drug Related Deaths

The annual <u>Drug Related Deaths</u> report was produced sharing the stories of those whose deaths were drug related during 2023. The report is available on our website along with reports from previous years.

Too many people still die from a drug-related in Cornwall. In 2023 there were:

- 42 deaths related to drugs and alcohol (31 men, 11 women)
- 2 deaths involving new synthetic opioids
- 17 deaths involving cocaine

We continue to review and learn how we might improve our prevention, as a matter of priority. Priorities for 2024/25 include:

- reviewing all non-fatal overdoses, to identify how we might impact earlier,
- continuing to increase the availability of naloxone
- developing understanding of how childhood trauma impacts upon peoples' vulnerability to drug and alcohol problems and death






Synthetic Opioids

With the reduction in the availability of heroin from Afghanistan, we have seen a rise in the supply of synthetic opioids in the local drugs market and their associated, much increased, harms.

We have rehearsed, with Emergency Management, for a major drug related incident as a result. This included colleagues from treatment, NHS, Police and the Ambulance service.

Work was also done with the police to establish a more effective drug testing pathway to ensure we can test these substances to establish an earlier warnings system, should they appear locally.



The Local Drug Information System was included in the response protocols., to ensure that information and alerts are cascaded effectively.


Promotion of the system to professionals was a focus this year to ensure people knew how to report any intelligence related to drugs and the responsibilities of named delegates in the cascade system for drug alerts. The priorities for next year will be on further promotion especially to the public and ensuring drug alerts reach those taking drugs recreationally who are less likely to be in support services.



Inpatient and residential rehab

125 people required an inpatient detox at our local specialist unit at Bosence

115 people required Residential Rehabilitation

We continue to exceed national targets and performance for uptake of inpatient and residential rehab.







Continuity of Care (CoC)

An integrated care pathway from prison to the community is crucial for supporting recovery from problem drug/alcohol use and reducing reoffending among people leaving custody. those who leave prison are at increased risk of relapsing including overdose and drug related death. Continuity of care means people leaving prison with a substance treatment need are referred to community treatment pre-release and then receive a priority appointment with the community treatment provider within 3 weeks of release. This has been a priority for improvement in the last year.

The community provider in Cornwall, With You, has a dedicated Criminal Justice Team who work closely with the prisons to provide continuity of care for all people leaving prison who are returning to Cornwall.

- The commissioning team have pulled together a local steering group with members from prisons and treatment services to identify the barriers and issues related to CoC.
- The community provider delivered regular in-reach within the local prisons.
- Good working relationships have been established between prisons and community
- Better understanding of processes and practices within prison and community has been facilitated
- Inappropriate referrals have been reduced.
- There is now more joint ownership of referrals.

All of this work has led to an increase in CoC for prison leavers, from 42% in 2023 to 58% in 2024. CoC in Cornwall and Isles of Scilly is now above the national average (54%). This is part of our approach to ensuring that people can be engaged in treatment at every stage of the Criminal Justice System (CJS).

Continuity of Care from community into prison and on discharge .






Individual Placement & Support (IPS) Employment Grant

- IPS is an employment support approach that offers intensive, individually tailored support to help people in treatment to choose and find the right job, with ongoing support for the employer and employee to help ensure the person sustains their employment.
- The distinguishing feature of IPS is that employment support is provided alongside clinical treatment.

Housing Support Grant

- Cornwall has a higher rate than nationally of households owed a statutory housing duty who also have an alcohol/drug dependency.
- 17% of those in treatment have a housing need.
- The grant is paying for more staff in housing and treatment including a dedicated team to support vulnerable women.

The Test and Learn approach is bringing agencies together to prioritise improving support and help to people who have experienced multiple evictions or have been unable to sustain a tenancy.





Workforce development

Upskilling the workforce to work with multiple vulnerabilities

In 2023/24 we **delivered 217 training courses to 5,003 staff** (compared to 269 courses to 4,165 staff in 2022/23). Our training programme is hybrid offering both online and inperson training sessions for the majority of our courses. This is to support different learning styles and work around people's preferences.

- Children -Increasing the rollout of education programmes for schools and outreach with young people at risk of or impacted by alcohol and other drug problems
- Reducing drug related deaths, including promotion of the Local Drug Information System to increase reporting and rollout of increased Naloxone provision to support reducing drug related deaths
- Continuing to improve the quality and effectiveness of Treatment and treatment progress for individuals by prioritising improvements in mental health, employment and housing and reducing caseload sizes.
